Rumble by the River 2019 Vendor Agreement

Dates: July 12th and 13th 2019

Location: Village Park, W230S9185 Nevins Street, Big Bend, WI 53103

The Village of Big Bend Celebrations Committee has space available for up to 8 vendors each night.

Vendor required hours 4pm to 10pm. Our event takes place rain or shine.

All vendors must be in their assigned area no later **than 4:00pm** the night of the date given, or you will not be allowed in and no refunds will be given. Vendors will not be allowed to leave their area until 10pm

Vendors will be limited to one of each type of vendor per night. EX: One Popcorn Wagon, one peanut guy, one Jeweler and so on. Type of vendor will be determined by committee

Fees are for one night only. If two of the same type of vendor sign up, you will be assigned a night. If more than 2 types of each vendor signs up, names will be placed in a hat and drawn at random and then assigned a night. If only one type vendor signs up you may purchase both nights at a discounted rate.

Vendors may not sell any food/snacks or merchandise that directly competes with our own items.

All vendors MUST provide proof of insurance, as well as all necessary certifications and licenses from the respective county and/or village agencies

Fees:

Fees are for a 10x10 area and will include parking for one vehicle and up to 2 people. All fees are nonrefundable for any reason. These spots do not have electricity or water, nor do they provide shade/rain protection of any type. Vendors may setup a canopy of the pop up style. No pole tents with guy/tension wires will be allowed.

Fees will be due at time of acceptance

Food vendor \$75 first night \$125 if both nights are open

Nonfood vendor \$40 first night \$65 if both nights are open

Food trucks \$150 first night \$225 if both nights open.

Vendors can submit their vendor forms with what options they would like up to June 7th 2019 and will be notified by June 21st 2019 with the options that they will receive. All fees will then be due no later than June 28th 2019 or your spot will be given to the next vendor.

Big Bend Celebrations committee reserves the right to deny access into the event for any reason at any time. Celebrations committee also reserves the right to ask any vendor to leave the event early for any reason. We provide equal opportunities without regard to race, color, religion, national origin, gender, sexual preference, age or disability. Vendors are responsible for their actions. Dishonesty and unacceptable behavior will be handled by law enforcement.
